*The Newfoundland and Labrador Psychology board (NLPB) has established a new more efficient, streamlined, mobile and revised application process for our applicants. We have partnered with the Association of State and Provincial Psychology Boards (ASPPB) to process our applications through their Psychology Licensure Universal System (PLUS) program. As a result, the application process will provide you with a permanent record of your application and supporting documents that will be retrievable from ASPPB for the rest of your professional career and provide you with the ability to easily apply for mobility services in the future.*

*Please be advised that it is the applicant's responsibility to ensure all documentation is complete. Applications are reviewed when ALL required documentation has been received by the Registrar. Please allow six weeks for the review process.*

### **Application fees:**

*The cost for the PLUS system is currently \$200.00 (USD) with an additional \$100 payable to the NLPB to cover administrative costs.*

*To begin the PLUS process, please complete this "Application for Registration as a Psychologist through the Psychology Licensure Universal System (PLUS)," submit it to the Newfoundland and Labrador Psychology Board by email to [registrar@nlpsychboard.ca](mailto:registrar@nlpsychboard.ca), or by regular mail to the address below. An ASPPB PLUS Licensure Specialist will contact you directly with further instructions.*
